PRESIDENT'S STATEMENT

Distinguished Delegates,

It is with great pleasure and honour that I welcome you all to yet another Annual General Meeting marking the end of year 2018, the second to be held at this magnificent Football Hotel. Let me once again use this opportunity to thank you all for giving me and my team a new mandate following our landslide victory in the 18th August 2018 polls. The Elective Congress has been described as the best organised, most transparent and fair ever in the history of Gambian football and, this was corroborated by representatives of both CAF and FIFA who attended the elections as observers.

There is no gainsaying that as one of the most important activities in the GFF Calendar, the AGM is a constitutional requirement where the Executive Committee present a Report on the activities of the Federation during the past year, the Draft Budget for the coming year and the Audited Financial Report of the preceding year for the approval of the General Assembly. I am proud to state the GFF under my leadership hasn't missed a single AGM since 2014.

As you would agree with me, 2018 has been the most turbulent year, but yet one of the most successful for the Federation.

Before going further, let me reassure Members of my administration's continuous commitment in defending the GFF Constitution in football management in line with both CAF

and FIFA Statutes and the National Laws of The Gambia. The GFF under my leadership continuous to place a very high priority, and will never deviate from it, in articulating our core competency in terms of good governance and prudent financial management system. We will also never relent in forging genuine partnership with stakeholders, including the Government of The Gambia and the private sector.

Significant progress has been made in the consolidation of the remarkable gains made in terms of football infrastructural development with the ongoing upgrading of six mini stadiums within the Greater Banjul Area and the construction of new mini stadia in Busumballa, Gunjur, SereKunda Central and NTTC. The first phase of the 15,000-seater capacity Soma Mini Stadium is com-

pleted and plans are underway to begin the next phase while the Federation has also secured funding to develop new grounds in Kwinella, Farafenni, Bullock, Bansang and Basse. During the year under review, there were also significant gains in grassroots football development, which once again resulted in the successful implementation of the Schools Football Competition and the Super Nawettan. Several capacity building programmes were held during the course of the year which includes both coaching and refereeing courses. The most recent being the one day training courses for physical/fitness instructors and Goalkeeper Trainers conducted by professional expatriate trainer from South Africa and Germany respectively.



On Women's Football, in addition to another successful League Season, we are able to secure the services of a German born expert, Ms. Monika Staab for a two-year project for Women's Football development. This project which was initiated by the GFF through the Gambia National Olympic Committee was formally signed by our Ministry of Youth and Sports and the German Federal Ministry of Foreign Affairs. The project which has since taken off will culminate in a series of training and capacity building activities for both technicians and administrators in Women's Football as well as public awareness in women's football.

For the first time in the history of The Gambia, the domestic league will take the shape of a national character with Kiang West and Second Infantry Battalion Football Clubs of the Lower River and North Bank Regions respectively, currently participating in the GFF Second Division League after winning their respective regional leagues. During this season as well, league matches will be played in Soma, Lower River Region. The champions of Upper and Central River Regions will also qualify for the 2019/20 season in the second division. The 2018/19 season has also seen the increase of the first division from 12 to 14 teams and the Second Division from 14 to 16 teams. Plans are at an advanced stage to launch the first ever professional league starting in the 2020/21 season and this will be opened to all clubs in the first and second divisions which would meet the eligibility criteria. A new end of season competition will also be introduced in honour of the late Alhaji Omar Sey for his contribution to the development of football in The Gambia and Africa as a whole. The competition will see the first eight teams in the First Division taking part in it.

The Football Hotel has also been operational for over a year now and while it is helping in the accommodation of our various National Teams, thus saving a lot of valuable resources for the Federation, it has also started to serve its purpose of being one of the major sources of income for the GFF, and this will gradually reduce our financial dependency on FIFA, CAF and the

Government. In fact it has been one of the major reasons why we were able to honour our National Teams' commitments in 2018. Funding has also been secured to construct a swimming pool at the hotel and it is our belief that once this is done, the facility would be able to lodge our Senior National Team and attract more guests from the public.

Despite all the obstacles, one of our biggest strengths is being firm on our beliefs and this has recently secured us a first competitive victory in five years for the Senior National Team (SNT). The SNT is a work in progress and with the young and exciting talents at our disposal, we can build on the strong foundations laid for future success. The U-20 Team also won the WAFU Championship in Liberia while the Women U-17 and Senior National Team both came to within a whisker of securing qualification to the World and African Cups respectively before failing at the last hurdle to more established teams in the shape of Ghana and Nigeria. The Men's U-17 Team also participated in the WAFU A qualifiers in Senegal but unfortunately we were forced to withdraw the Olympics Team from the competition due to funding difficulties.

To ensure better efficiency and productivity, a new organo-gram has been developed and approved by the Executive Committee. Among the highlights of the new organo-gram is the establishment of a Marketing and Communications Department now headed by a Director with a Marketing Manager and two Communication Assistants to be appointed in 2019, and a new Human Resources and Admin Manager will be recruited in the New Year. This will consolidate the gains made in our communication and open door policy by further bringing the activities of the Federation to the doorstep of stakeholders and the general public. The Department has launched an in-house Youtube Television Channel for the GFF. There will also be wider coverage of all our competitions beginning this season. The Communications Department have also introduced a semiweekly talk show on our Youtube channel where they review and preview the week's activities of the GFF, especially the domestic

league. This has been ongoing now and it is aired on Mondays and Thursdays at noon. For the first time all our international matches and finals, except where rights are restricted, have been streamed live. The positions of Transfer Matching System (TMS) and IT Manager have been merged and this will save a lot of valuable resources for the Federation and usher in more efficiency. Recalling the past challenges, and to ensure better service delivery and efficiency at the Competitions Department, a new Director of Competition will be recruited in the New Year as well as two Competition Assistants responsible for Technical and Administrative matters respectively.

Following the end of the contract of the former holder of the National Team job and his subsequent appointment as the Technical Director of the GFF, a new coach has been recruited in the person of Mr. Tom Saintfiet who has vast knowledge in African football management on a nine-month contract through the qualifiers for the 2019 TOTAL Africa Cup of Nations. After back-to-back draws with Algeria and Togo and a home defeat to the latter, he secured his first win in the qualifiers with an emphatic 3-1 come from behind defeat of Benin in Banjul last month. This has kept alive the possibility of our first ever qualification to the AFCON finals.

I am pleased to announce that the Government has started to retake its responsibility by footing the bills for the last game against Benin.

Notwithstanding, 2018 been an election year for the GFF, we've seen the stage where our local football politics has reached. There were various futile schemes deployed by certain people in positions of authority and their protégés cooking up unsubstantiated allegations against me and members of my Executive just to avert the election process because they knew that they had no chance of winning the elections.

You would all recall that it was in this same hall in February this year when you elected an independent Electoral Committee and the Electoral Appeals Committee which are mandated to organise and supervise the election process and take all decisions relating to elections within



the GFF. However, following the disqualification of five candidates from the opposing camp and one from my team for failing the first ever Eligibility Check, the former quintet took an internal football matter to the ordinary courts following an unsuccessful appeal at the GFF Electoral Appeals Committee, which is a serious violation of Article 65 of the GFF Constitution. They tried to stop the elections through a restraining order/injunction from the High Court on two occasions to no avail and later judgment was delivered in our favour. Consequently, following their failure to withdraw the case until judgment was pronounced, and sequel to their earlier suspension from the GFF, the below listed people have been expelled from the GFF in accord-

ance with Articles 65.1, 65.2 and 65.3 of the GFF Constitution: Mr. Kaba Ceesay Mr. Abdoulie Njie (Star) Mr. Musa K. Jawara Mr. Essa Jallow Ms. Mariama Jobarteh Despite all the obstacles, we've always maintained that we never had a problem with Government of The Gambia or any of its agencies but rather a few individuals who think that they've a birth right over the direction of Gambian football aided by the erstwhile Minister of Youth & Sports who never gave us any chance throughout his tenure in office. However, following the appointment of the current Minister, everyone has seen a new found relationship between us based on genuine partnership. In fact, his intervention during those torrid moments helped in averting a

potential serious trouble between The Gambia and FIFA and all genuine stakeholders, including myself, are grateful for this. Let me in conclusion assure the Government and the Minister of our continuous collaboration and partnership in the development of football in the country. For you the stakeholders, I wish to renew our pledge to continue the path of development we have chosen in the past years, which are evidently yielding positive results now. I have no doubts that in the very near future, our football will reach a stage to the pride of all of us. I wish you all a very healthy and successful AGM. Long Live GFF Long Live Football Long Live The Gambia. I thank you all.

Organisational Transformation

2.1 STAFF MATTERS

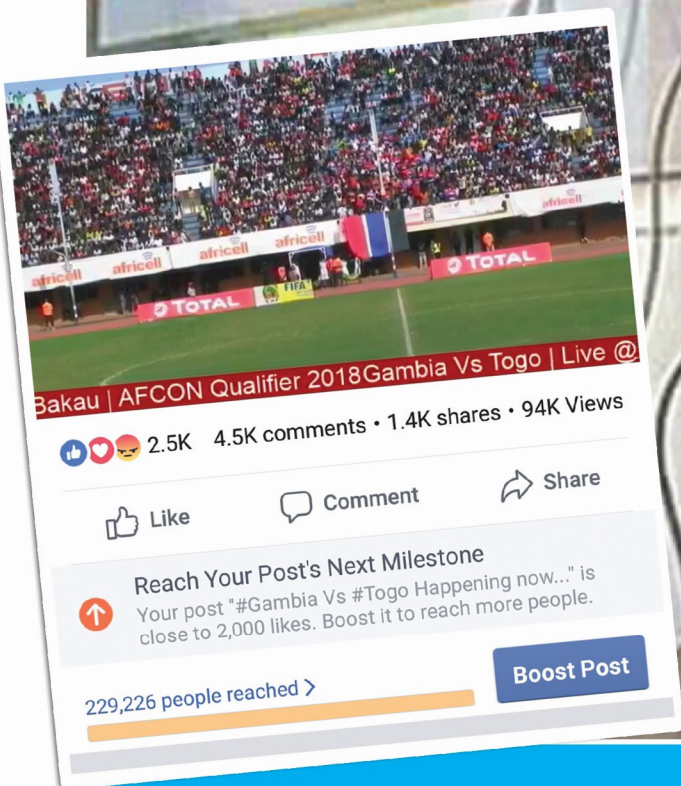
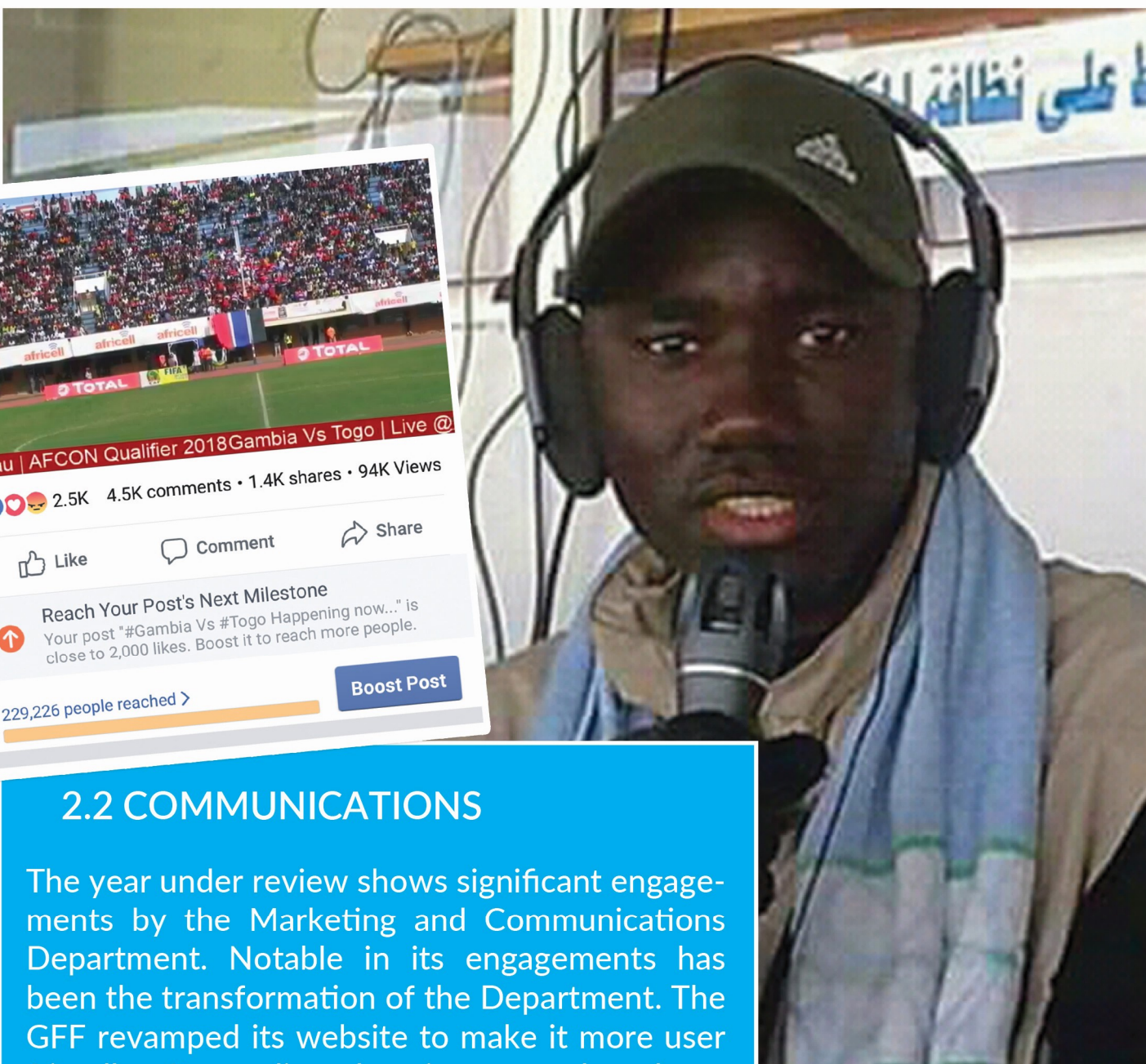


At the beginning of the year, a new General Secretary was appointed with significant experience in football administration.

A new Technical Director was also appointed. During the year, the GFF was committed to sound management and administrative practices which clearly promotes separation of duty between the elected Executive Members and staff of the Secretariat.

Regular Management meetings are held, a new organogram adopted, establishing the Marketing & Communications Department, expansion of the Competitions Department to include a Technical and Administrative functions. The position of Transfer Matching System (TMS) and IT Manager has been merged.

Capacity building remains one of the most important components of Football Development.



2.2 COMMUNICATIONS

The year under review shows significant engagements by the Marketing and Communications Department. Notable in its engagements has been the transformation of the Department. The GFF revamped its website to make it more user friendly. Its earlier domain name has been changed to www.gambiaff.org and this is streamlined with a Facebook page and twitter handle to maximise publicity, promotion and information sharing on all our platforms to our stakeholders and the general public.

3. Youth & Grassroots Football Development

3.1 Principal's Cup

The Gambia Football Federation through the School Football Association in collaboration with Guaranty Trust Bank (GTBank) staged the third edition of the Principals Cup school football competition at the Independence Stadium in May 2018. The competition attracted schools in the Upper Basic and Senior Secondary Schools from all the regions in the country who played in a knockout qualifier with the last eight teams each for boys and girls qualifying for the final states of the competition.

Bottrop Senior Secondary School were crowned champions in the male category, beating Bakoteh Senior Secondary School three 3-1 while Gambia Senior Secondary School overcame Bottrop 1-0 in the female category. Our relationship with all media

3.2 Super Nawettan

The 2018 Super Nawettan competition witnessed the increment of teams as part of the decentralisation of the competition. In a bid to expand grassroots football and strengthening the vision of the GFF

Executive Committee in ensuring that the competition takes a national character, the Super Nawettan Committee for the year under reviewed increased three Nawettan centres to the competition with the inclusion of Sanyang; Farato-Busumbala-Yundum (FABY) and Jarra

and Kiang United (JAKU), making it 16 teams. Serrekunda East defeated Brikama in a post-match penalty shoot-out following a 1-1 draw in regulation time. Banjul lost 2-0 to Manjai in the third and fourth place playoff.



3.3 Grassroots Coach Education - D Licence

A three-day 'D' Licence coaching course was organised by the Technical Department in collaboration with The Gambia Football Coaches Association at the Football Hotel in Yundum from the 8th - 10th May 2018. The course brought together twenty-six (26) coach participants in which twenty-three were Gambians and three South Koreans from the first, second and third division leagues in addition to other coaches from football academies within the Greater Banjul Area. All the coaches that attended the programme were registered members of their respective regional coaches association.





4. Women Football Development

4.1 National First Division League (Women)

The women first and second division leagues were keenly contested and completed successfully. Red Scorpions won the first division. Interior emerged as the runner up. Interior denied Red Scorpions from winning the double after edging out the league winners on post-match penalty shootouts in the FF Cup finals.

4.2 National Second Division League (Women)

In the second division, City Girls emerged champions and gained promotion to the first division. The second division is now increased



from six to eight teams accommodating Greater Tomorrow and Raptim FC; the WCR and KM third division champions respectively.

4.3 NATIONAL WOMEN'S TEAM

The National Women's team was registered for the AFCON qualifiers to further strengthen the women game. Coach Mariama Bom Sowe was appointed as head coach of the

team. Players were selected and the team started their preparation for a series of test matches before the competition.

BISSAU 1 – 4 GAMBIA

The Women's Scorpions was invited for a friendly by Guinea Bissau for what would be a return match of the game played at the Independence Stadium. The Gambia annihilated their hosts 4-1 in.

MOROCCO 2 – 1 GAMBIA

Fresh from crushing Bissau, the Women's Scorpions continued their preparations to face Burkina Faso in the first leg of the qualifiers. The Federation through their MoU with the Moroccan FA airlifted the team for a training camp in Morocco before proceeding to Burkina Faso for the first leg match. We lost 2-1 in a friendly.

BURKINA FASO 2 – 1 GAMBIA

The team left Morocco and jetted in Ouagadougou to play in their maiden appearance at senior level in the AFCON qualifiers. It was the Gambia that took the lead courtesy of an Adama Tamba goal before the host rallied back in the second half to turn the match on its head. The Gambia ended the game with nine women.

GAMBIA 2 – 1 BURKINA FASO

With the spirited display in the away leg, the team returned home with high hopes in preparation to eliminate their opponents and advance to the next stage of the competition. It was exactly what happened as they defeated Burkina

2-1 with both goals scored by Adama Tamba. The Women Scorpions prevailed on the post-match penalty shootout.

GAMBIA 1 – 2 MALI & GAMBIA 0 – 2 MALI

Eliminating Burkina Faso means Gambia now faces Africa's big gun, Nigeria to fight for a place in the tournament proper. The Gambia then took on highly rated Mali at home in what would be a test to prepare for the Nigeria game. It was the Malians who won on both matches winning 2-1 and 2-0.

GAMBIA 0 – 1 NIGERIA

The Gambia hosted Nigeria in the first leg and the visitors with Africa's multiple times player of the year Assisat in their squad were given a night to remember as the Gambian proved a tough knot to crack and losing only 1-0 to the surprise of many. Their performance impressed many and the team was tipped to be a force to be reckoned with in the future.

NIGERIA 6 – 0 GAMBIA

After the impressive performance against the Nigerians in The Gambia, the national Women's Scorpions were mobbed by their host six goals to nil in the away leg. The 7-0 aggregate win ensured Nigeria's qualification to the tournament.

As a result of our performance in the qualifiers, we were included in the world rankings for the first time. We were ranked 135.

4.4 WOMEN'S U-17 TEAM:



GAMBIA ADVANCED 6-0 ON AGGREGATE

The Gambia National U-17 Women's team was registered to take part in the AFCON qualifiers with coach Abdoulie Bojang appointed on an interim basis to take charge of the team. The Gambia was paired with Sierra Leone in the preliminary rounds and we won 3-0 in Freetown. The Sierra Leoneans failed to show up for the return leg and we were awarded a 3-0 win in default to advance 6-0 on aggregate.

GAMBIA 1 - 5 GHANA

After that convincing away win in

Sierra Leone, the team faced the herculean task of meeting Ghana in the next stage. The Ghanaians with their experience triumphed 5-1 at Bakau's Independence Stadium.

GHANA 2 - 0 GAMBIA

Coach Abdoulie Bojang and his team were able to learn from the lessons in the home game by putting up a brilliant performance in Ghana to reduce the scoreline by conceding two late goals thus lost the game but with heads held high up.

4.5 Women Football Outreach Programme

The women Football coordinator together with the women football ambassadors conducted an outreach programme for the promotion of women football in the West Coast Region in collaboration

with the West Coast Regional Football Association. 70 girls drawn from lower and upper basic schools participated and were introduced to the Technical and tactical Activity of the game.

Programme Objectives is aimed to:

- Enhance Women Football Development in the country
- Create awareness and promote the Women game
- To encourage promising young girls to play and remain in football
- To identify and Nurture young promising talented female players



5. National Football Development

5.1 GFF DOMESTIC COMPETITIONS

National First Division League (Men)

The domestic league competition for men started with the annual Super Cup as the traditional curtain raiser and as usual was played between the league and cup champions GAF FC and Hawks respectively at the Independence Stadium in Bakau, with the latter emerging victorious. The Season was successfully completed with Gamtel/Gamcel FC crowned champions and GAF FC clinched the FF Cup after beating

Brikama United with the narrowest of margins in a seven goal thriller.

National Second Division League (Men)

In the second division, Samger Football Club won the competition and Wallidan FC finished second. The conclusion of the 2017/18 leagues witnessed the increment of teams in both the first and second divisions as agreed during the team management (preseason) meeting. The first division is now increased to fourteen (14) teams. Four teams were promoted from the second

division and they are: Samger, Wallidan, BK Milan and PSV Wellingara while Steve Biko and Bombada dropped down to the 16-team second division. The champions of Banjul, Kanifing Municipality, West Coast Regions promoted to the second division and for the first time two teams from the provincial Gambia; 2nd Infantry Battalion from the North Bank Region and Kiang West of the Lower River Region gained promotion to League Division Two while KM based team Serrekunda United dropped to the third division.





5.2 INTERNATIONAL ENGAGEMENTS

MEN'S SENIOR NATIONAL TEAM

GAMBIA 1- 1 ALGERIA

Following the appoint of Tom Saintfiet as the Head Coach, the Belgian began his tenure with a 1-1 draw with Algeria in Bakau's Independence Stadium and the Stadium was filled to the brim. This will mark the beginning of something unusual for Gambian football, the knack to come from behind by turning defeat situations into either wins or draws.

TOGO 1 - 1 GAMBIA

In the next game in Lome against Togo, the Scorpions scored an early goal and were smelling a vital away win that would've boosted our chances of securing a place in the 2019 AFCON in Cameroon but a free-kick with just four minutes remaining broke Gambian hearts and ensured parity for the remainder of the match.

GAMBIA 0 - 1 TOGO

The two sides squared off in Banjul few days later for the return leg and if not for their profligacy in front of goal, all three points would've stayed at home but a last minute goal condemned us to defeat in front of the home faithful.

GAMBIA 3 - 1 BENIN

The Scorpions regrouped a month later in Banjul and on the 17th November, 2018, history was made when the team registered its first competitive win in five years. Despite dominating for the whole of the first half, the Scorpions went behind in the first half. Tom Saintfiet's charges regrouped in the second half and exhibited what many described as footballing excellence by scoring three unanswered goals inspired by two substitutions that would remained on the lips of most spectators for the longest time.

In what many described as one of the greatest comebacks in Gambian football, Lamin Jallow ensured parity just past the hour mark with a deflected effort. Babucarr Jobe gave Gambia the lead for the first time in the match with a fierce low drive effort before Ablie Jallow made sure of the three points with the simplest of finishes when Jobe's effort ricochet off the post in the dying seconds. This has rekindled our hopes of qualifying and depending on the outcome of the protest we lodged against Togo, a 1-1 draw in Algeria could see us through on the number of goals scored.





5.3 U23 National Team



The National U-23 team headed by Coach Omar K. Sise hosted their Moroccan equivalents in two test matches earlier in the year. Following a goalless stalemate in the first match, Atalanta forward Musa Barrow scored the all-important goal as the team secured a confidence boosting 1-0 win in the second encounter.

5.4 U20 National Team



WAFU CHAMPIONSHIP

The National U20 team took part in the WAFU U-20 tournament held in Liberia in April. The team, headed by Coach Mattar M'Boge was drawn in Group B comprising of Senegal, Mali and Guinea. The Gambia played a 1-1 draw with Guinea, followed by a goalless stalemate with neighbours Senegal before beating Mali 1-0 to qualify for the semifinals. Ivory Coast was the next victim in the last four with a 6-5 post-match penalty win. The Young Scorpions defeated the hosts 2-1 in the finals to win the WAFU Cup for the first time ever.



The U-20 team later started its preparation with a 2-1 defeat of Benin at the Independence Stadium. The team was unable to advance to the next stage as they lost 2-0 in the away leg.

5.5 U-17 National Team



Abdoulie Bojang is appointed on a two-year contract as the U-17 Coach. He and his team took part in the WAFU A U-17 competition held in Senegal which also served as the qualifiers for the AFCON U-17 championship in Tanzania 2019. The team was paired with Mali and Liberia in Group C but Liberia withdrew leaving only two teams in the group to play a knockout game with the winner qualifying to the semifinals. The Gambia lost 2-0 to Mali and were eliminated.

5.6 CAF CLUB CHAMPIONSHIP

League champions GAF and FF Cup Winners Hawks were the Gambia's representatives in the CAF Champions League and Confederations Cup respectively. The Soldiers were paired with Zanaco of Zambia who triumphed 6-1 on aggregate. Hawks produced a remarkable performance in Nigeria beating Akwa United 2-1 but failed to advance to the next stage when they lost 2-0 in the reverse fixture in Banjul.

5.7 TECHNICAL DEVELOPMENT



A day's workshop was convened by the GFF Technical Department to introduce the new GFF Technical Director. This was in conjunction with the GFF Regional Coaches held at the Football Hotel in Yundum. The workshop brought together all the nine (9) coaches within the respective Regional Football Associations to also review the Regional Coach Educators handbook and reintroduce the GFF School and grassroots football document. The day's event was also used to start the implementation of a three-month pilot programme on grassroots and youth development based on the GFF grassroots and youth football handbook. The training followed the presentation of training materials for use by the coach educators in their activities.

As a practical activity, a session was organised to introduce some technical drills suitable for youth training to the coaches. Some female players from the women league were brought in to train and demonstrate while the coaches observed and took note.

COURSE OBJECTIVE

The course was geared towards building the capacity of coaches in teaching them introductory coaching and formally kick starting their careers. The programme was also meant to strengthen grassroots and youth football development as the majority of the coaches mainly deals with young players. It is also used to prepare coaches for CAF Licence programme.

5.8 REFEREES EDUCATION

During the period under review, the Referees Manager went on statutory retirement and a new holder of the position of appointed beginning April 1, 2018. However,

there was an acting Referees Manager from 1st January 2018 to 31st March 2018.

A new Refereeing Seminar was convened by CAF and attended by Gambian Referee Fatou Ngum in Cairo. An Elite Referees Course also took place in Kigali, Rwanda and the Gambia as active participants were also represented by Assistant Referee Sulayman Sosseh from the 5th to 11th August, 2018.

Two other Gambian Referees Omar Sallah and Assistant Referee Abdul Aziz Bolel Jawo were appointed by the West Africa Football Union (WAFU) Zones A and B as designate Referee and Assistant Referee to the WAFU Tournaments in Senegal and Niger.

Gambian Referee Bakary Papa Gassama was also selected by FIFA one of the two CAF referees for the FIFA World Cup Russia 2018. As such, the GFF and the Gambia Football Referees Association & Committee threw a cocktail dinner for Gambia's best and Africa's finest referee held at the Football Hotel in Yundum. The three times CAF Referee of the Year Award winner later flew to the summer football tournament in Russia where he officiated one game. It was his second consecutive World Cup appearance following his experience in Brazil four years earlier.

The dark side of the year under review has been the suspension and eventual ten year life ban imposed on referee Ebrima Jallow from all football activities by CAF for his involvement in the bribery scandal exposed by a Ghanaian undercover journalist Anas Ayeremang Anas at the WAFU tournament held in Ghana 2017.

The GFF recused Mr. Jallow from all football matters pending the outcome of CAF's investigations into the matter.



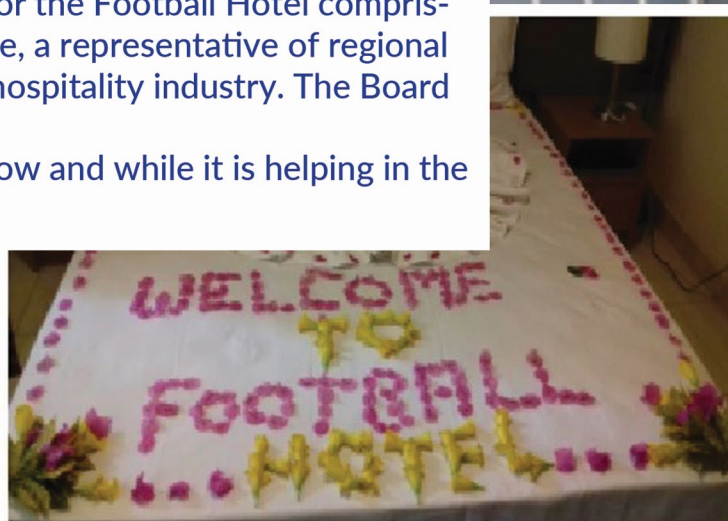
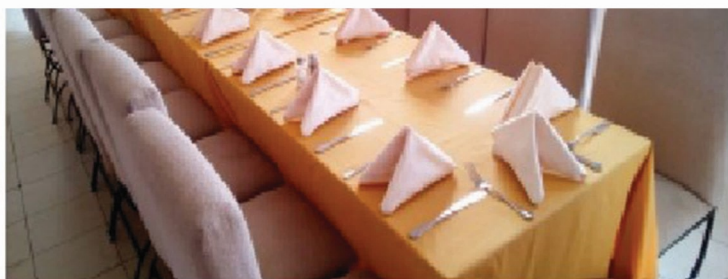
